The Financial Statement for 2003-2004 shows a deficit of USD 48.719:- compared to budget deficit of USD 21.500:-. This is of course serious but is explained by some occasional items:

- Change in reporting system so that all revenues and expenses are reported on the period they occur. Previously WMA worked with accruals to report Championships revenues/expenses at their periods but the new contracts with payments by LOCs before the Championships, USD 50.000:- (Riccione 1st instalment) have made a change necessary.
- Consequently all cost accruals for future Championships, USD 26.500:-, have been charged against 2003-2004.
- Lower attendance at the World Championships Stadia in Carolina, less athletes' fees USD 9.500:-.
- The low attendance at the World Championships Non-Stadia in Manukau/Auckland gave USD 29.000:- less in athletes' fees than budgetted.
- Costs for the 1st World Championships 100K in Tainan, USD 4.500:-, were not included in the budget.
- Increased costs, USD 13.000:-, for Council attendance both at the 1st World Championships Indoor in Sindelfingen and the following Council meeting in San Sebastian.
